- (6) Failure to yield in violation of I.C. 9-21-8-29 through I.C. 9-21-8-34 and/or
- (7) Failure to obey a traffic control device in violation of I.C. 9-21-8-41 and/or
- (8) Driving at an unsafe speed in violation of I.C. 9-21-5 and/or
- (9) Repeatedly flashing the vehicle's headlights
